11.2.1 Proportion of population that has convenient access to public transport, by sex, age and persons with disabilities

- For clarification/ limitations
 - Frequency
 - No frequency for global comparison
 - Use from Sweden's proxy indicator (once an hour from 06-20 working days)?
- Results/ disaggregation/ regional level
 - A lot of suggested disaggregation levels, what is relevant for Europe?
 - Is regional level more important than the suggested disaggregation groups?
 - You have to know which populated areas there is a deficiency in access, but do you need to know more to take relevant action?
 - To prioritize where to improve the service, it may be important
 - What regional level to produce results?
 - NUTS/LAU/grid



11.3.1 Ratio of land consumption rate to population growth rate

- For clarification/ limitations
 - Which land use/ cover classes to include
 - Only urban land or roads/airports etc?
 - Parks and playing grounds
 - Even agriculture and forestry has been mentioned
 - Which methodology for urban delimitation (also 11.7.1)
 - TERCET 1km grids for comparability?
 - National delimitations for analysing the above
- Results/ disaggregation/ regional level
 - GHSL (Global human settlement layer) and national data?
 - NUTS/LAU/Grids?



11.7.1 Average share of the built-up area of cities that is open space for public use by all, by sex, age and persons with disabilities


- For clarification/ limitations
 - Open space
 - all open public spaces including street network (as described)
 - Or just green areas?
 - For public space by all
 - Open space potentially for public use? (avoid field inventories)
 - Open space <-> population
 - How to connect the space and people?
 - What data to use
 - Can the GHSL be used also in this context? (not just for urban but open)
 - National data sources (land use/ cover map)
- Results/ disaggregation/ regional level
 - Quality information on spaces may be difficult to obtain
 - City same as 11.3.1
